3.1 COVID-19 Protocols for Christmas Island

Members discussed developments on island regarding 'Essential Staff' exemptions and the impact this was having on local business and the community.

RESOLUTION

Arising from the possibility of community contact with "Essential Staff" who have received an exemption for the **continuity of business or government purposes** and are permitted to perform work within their 14 day isolation period, it is imperative that the following condition strictly apply to all Essential Staff.

- ADF and ABF Ship Crew change overs should occur with incoming crews transferred from the Plane to the Ships and outgoing crews transferred from the Ships to the Plane for immediate

flight off Christmas Island (no overnight stays). In any circumstance that changeover ship crews must overnight on Island they are to be transferred on a single bus to a Poon Saan Bed Sit and provided with food and necessities and not allowed to exit their accommodation. The following day they are to be transferred on a single bus from their accommodation to the Airport or the Ship. Their accommodation is to be locked for 4 days before thoroughly cleaned.

- Should Virgin or other Air Crews have to overnight they are to be transferred in a single bus from the airport to a Poon Saan Bed Sit, provided with food and necessities and not allowed to exit their accommodation. The following day they are to be transferred on a single bus from their accommodation to the Airport. Their accommodation is to be locked for 4 days before thoroughly cleaned.
- All other Essential Staff have to complete 14 day isolation (as is occurring with Essential Health Staff) before engagement on the essential work function for which they were given travel exemption.

Accordingly, the CCC has met via telephone hookup today and strongly recommends that the CI Territory Controller, the Administrator and the EMC implement the above conditions immediately.

The CCC will reconvene at 4.30pm tomorrow to consider its position if the above conditions are not implemented.
