4.1 COVID 19 Island Management

The CCC were presented with a copy of Dr. Rosemarie LEE's response to the CCC questions on COVID19 Island Management from the May 6th CCC meeting. The Chair received these on 26th May. The Chair noted that these responses had been published in The Islander of 29th May 2020. The Chinese and Malay translation of the responses will be published in the next Islander of 12th June 2020.

The CCC presented with a copy of the IOTHS Escalation Plan for COVID19 that was referred to in Dr Rosemarie LEE's response. CCC also presented with a copy of the COVID19 safety guideline docs that the Emergency Management Committee have made available to guide restaurants and venues to opening back up according to the rules in place to do so.

The CCC resolved to put new questions to Dr. Rosemarie LEE based on developing situations arising in this area. Group decided to inquire with Dr. Rosemarie LEE if she had availability the next day 4th June 2020 noting that she may have to also schedule it with her line manager Jadranka MATIJAS as previously advised.

4.2 For Information: Australian Electoral Commission may reduce number of House of Representatives for the NT from two to one

CCC presented with article '*Race to change law that could leave NT with one less MP after AEC redistribution plan,*' from the Daily Telegraph, 26.5.2020. Members discussed the reduced level of representation for Christmas Island if the Lingiari Electorate had to additionally cover the Solomon Electorate which is dominantly Darwin and the surrounding areas.
