4 Agenda Business

4.1 Abbott's Booby Conservation Draft Advice.

Gordon **THOMSON** updated CCC on the following:

Following the report at the last meeting where it was reported that at the first of the monthly phone meetings between SOCI and DITCRD in October that a key action item was created for DITCRD to get legal advice on the standing a Conservation Advice has over planning; DITCRD responded at the 21st November LPS-CISA meeting that this advice was forthcoming still.

A meeting with Emma **CAMPBELL** and her colleagues from the Commonwealth Department of the Environment and Energy will be had tomorrow Thursday December 5th at the Shire; an invitation was sent to CCC members and Councillors to attend.

4.2 CCC Fisheries Petition

Chris **SU** informed the meeting that Council adopted the CCC's November 6th motion regarding a CI Fisheries Management Authority at its November 19th Council Meeting.

Council is going to action this request in coming weeks with the Minister. Chris **SU** to report back on Council's action.

4.3 Deloitte Tourism Review and Plan Presentation

Chris **SU** informed the CCC that the Deloitte Tourism consultants had informed him that they could not meet the CCC by email about a half hour before the meeting. Michael **MCCORMACK**, lead consultant, had verbally told Chris **SU** that **David EIZENBERG** from the Office of the Administrator had arranged another meeting for them for the same time. Chris SU noted that the cancellation email was cc'd to the Administrator Natasha **GRIGGS** and David **EIZENBERG**.

Consultants informed Chris SU that the CCC members could come to the public meeting at the Recreation Centre on Thursday 5th December from 4.30pm-6.00pm; Chris SU responded that the CCC were already in an engagement with the Department of Environment at that time (Abbott's Booby Conservation Advice meeting).

Chris **SU** recounts that he had contacted Deloitte on 27th November for a meeting for the CCC on 4th December and received a confirmation email from Sarah **CRISCI**, Deloitte Analyst on 28th November that they would meet the CCC on 4th Dec at the 4pm meeting.
