4.3 Service Delivery Agreement Review – Dept of Jobs, Tourism, Science and Innovation

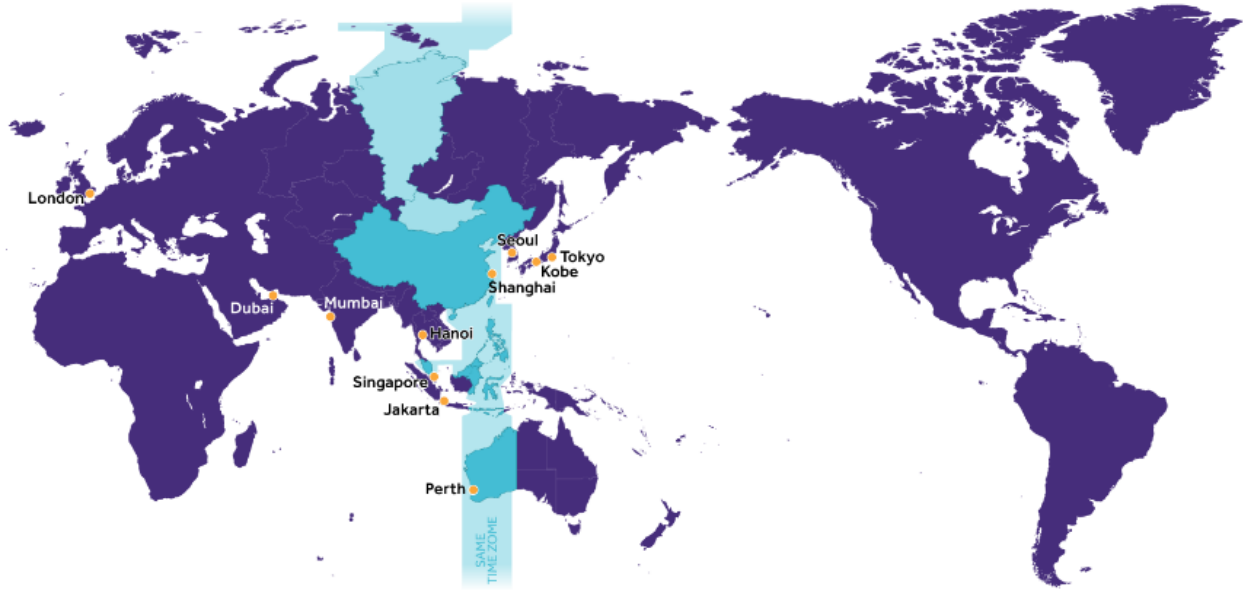
